

Minutes of Capital Review Committee Meeting
Tuesday, May 23, 2006

A Capital Review Committee meeting was held on Tuesday, April 11, 2006, at 1:30 p.m. in 123 Jesse Hall and the following was discussed.

1. Tiger Walkway – David Roloff

This request is to remove the current bricks in the sidewalk between the Reynolds Alumni Center north entrance and Conley Ave. replacing them with engraved bricks purchased by donors. The horizontal strips of concrete between the brick squares will be replaced by granite strips. Donations generated from the brick walkway program would go to benefit the MU Alumni Association.

Recommendation: CRC approved the removal of the current bricks and concrete strips in the sidewalk between Reynolds Alumni Center north entrance and Conley Avenue and to replace them with granite strips and engraved bricks purchased by donors. The Committee selected Plan Three which consist of replacing the original sidewalk layout with a design that would reduce the number of strip dividers from 14 to 6 with the MUAA Guideposts engraved on each one. Expand the number of threshold bricks to 60, expand the number of entryway bricks to 156 and expand the base bricks to 1,464. This brick option was presented to the Committee by David Roloff, MU Alumni Association.

2. Lafferre Hall – Reconstruct 1922 Addition – Schematic Design – Jude Wawrzyniak

This project seeks the approval of the schematic design and the authorization to present to the Board of Curators for approval at the July 20/21, 2006 meeting. This project includes demolition of the 1-story high-bay 1922 addition along with a small portion of the 1935 addition, totaling 25,086 GSF. The new construction includes a 3-story infill into the resulting void that will house research, instructional and student spaces totaling 30,074 NSF. In addition, there will be a basement level and mechanical penthouse level for a total project size of 60,974 GSF.

Recommendation: CRC approved the schematic design and authorization to present to the Board of Curators for approval at the July 20/21, 2006 meeting.

3. Various Locations – Outdoor Kiosk – Gary Ward

This project would install a free standing, outdoor information kiosk on the Arts and Sciences Mall, near the General Classroom Building. The kiosk is constructed of a painted steel frame with six posting panels, lighting, and translucent roof panels to provide weather protection and filtered light. This project was requested by the Office of Student and Auxiliary Services in order to provide an outdoor location to post information of interest to students. The kiosk will be lit after dark to extend the hours of use, enhance safety, and help reduce vandalism.

Recommendation: CRC approved the request as submitted.

4. Missouri Review's request for space in McReynolds Hall – Scott Shader

Scott Shader distributed a handout stating that the Missouri Review has been asked by Stephens College to vacate their leased space by no later than May 31, 2006. Scott stated that Missouri Review will be assigned rooms 350-357 and 450-457 in McReynolds Hall for up to three years. Scott stated that the Advisory Committee on Space has voted to endorse this request at their May 2006 meeting.

Recommendation: CRC approved the request for space in McReynolds Hall to accommodate Missouri Review immediate need for up to three years with the option for renewal.
